Sub Request for Quotations for Supply and Installation of Improved Fly Shuttle Frame Loom with accessories & Jacquard (Ball Bearing) with accessories for Bodoland Eri Mission (BEM) under APART in BTR

- 1. The Government of Assam (GoA) through the Government of India has received a loan of US\$ 200 million from the World Bank (WB) for implementation of the Assam Agribusiness and Rural Transformation Project (APART). The development objective of APART is "to add value and improve resilience of selected agriculture value chains, focusing on smallholder farmers and agro-entrepreneurs in targeted districts of Assam". The ARIAS Society now intends to apply a portion of the loan for Bodoland Eri Mission (BEM) of APART in BTR.
- 2. ARIAS Society invites quotations from eligible bidders for "Supply and Installation of Improved Fly Shuttle Frame Loom with Accessories & Jacquard (Ball Bearing) with accessories" for distribution to the beneficiaries under Bodoland Eri Mission under Assam Agribusiness and Rural Transformation Project (APART) for purchase of above items. The 80% cost of supply will be borne by the APART project and 20% of the cost of supply will be borne by the beneficiaries approved by the District Level Coordination Committees (DLCCs) of BTR, Kokrajhar.

SECTION 1

INSTRUCTIONS TO BIDDERS

1. This RFQ documents is in connection with "Supply and Installation of Improved Fly Shuttle Frame Loom with Accessories & Jacquard (Ball Bearing) with accessories" for Bodoland Eri Mission (BEM) under APART in BTR.

2. Preparation and Submission of Quotation:

- a) Quotation shall be addressed to "The State Project Director, ARIAS Society, Agriculture Complex, Khanapara, G.S. Road, Guwahati-781022 (Assam)."
- b) Quotations shall be submitted as per the format given at Annex- I along with other supporting documents as mentioned with a copy of the RFQ placed in a single sealed envelope, clearly marked as "Supply and Installation of Improved Fly Shuttle Frame Loom with accessories & Jacquard (Ball Bearing) with accessories" for Bodoland Eri Mission (BEM) under APART in BTR; Not to open before 16 August, 2024 at 11.15 AM." The name of the bidder, address and contact no. should be mentioned on the reverse of the sealed envelope.
- c) Bidders shall ensure deposition of their Quotations received in the office of the SPD, ARIAS Society on or before **11.00 AM** of the **16** August, **2024**.
- d) The bid security of **Rs. 82,000.00/- (Eighty Two Thousand only)** must be submitted along with the quotation by the eligible bidder.
- e) All pages of the quotation shall be signed and stamped by the authorized person to indicate that the bidder has agreed to all terms and conditions of the quotation. Overwriting, alterations, if any, in the quotation should be signed by the authorized signatory.
- f) Any quotation received after the dead line for submission shall be rejected & returned to the bidder.
- g) Quotation not accompanied by specified documents, self-declarations, signatures and signed copy of this RFQ may be rejected by the office as non-responsive and may not be evaluated.
- h) The quotation shall be prepared as per the technical specification provided at Annexure II.

3. Bid Security:

- a) The bid security must be submitted along with the quotation.
- b) The Bid Security must remain valid for a period of 45 (forty five) days beyond the original bid validity period or beyond any period of extension subsequently requested by the Purchaser.
- c) Any bid not accompanied with Bid Security shall be treated as non-responsive by the Purchaser.
- d) Unsuccessful bidder's Bid Securities will be discharged/returned as promptly as possible as but not later than 30 days after the expiration of the period of bid validity prescribed by the Purchaser.
- e) The successful bidder's bid security will be discharged upon the bidder being issued the Supply Order and furnishing of Performance Security by the Bidder.
- **4. Validity of Quotation:** Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission.
- **5. Opening of Quotation:** The quotations shall be opened in the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date.

6. The Quotation shall comprise the following:

- b) Signed copy of RFQ document.
- c) Evidence in accordance with <u>Clause 8</u> establishing Bidder's qualifications to perform the contract, if its quotation is accepted;

7. Quotation Prices

- a) The contract shall be for the full quantity as specified in the Price Quotation Form. Corrections of the quoted rate, if any, shall be made by crossing out, re-writing, initialing and dating.
- b) The rates quoted by the bidder shall be fixed for the duration of contract and shall not be subject to adjustment/modification on any account.
- c) 'Discount' or extra charges if any mentioned by the bidders shall not be considered unless these are specifically indicated in the price schedule.
- d) All duties, taxes (including GST) and other levies payable by the contractor under the contract shall be included in the total price.
- e) All the costs relating to transportation and delivery at the final destination: Bhergaon, Tamulpur Kokrajhar & Baksa Sub-division shall be included in the quoted price for the items.
- f) The Prices should be quoted in Indian Rupees only.

8. Qualification Criteria: to qualify for award of the contract, the bidder:-

- i. Bidder should be a manufacturer of equipment and accessories for Handloom for last 5 (Five) years, (FY 2024-23, 2023-22, 2022-21, 2021-20 & 2020-19). (Attach Certificate of incorporation and/or Certificate of commencement of business)
- ii. The bidder should submit the Udyam Registration certificate from the competent authority. (Documentary evidence to support the same)
- iii. The bidders should have minimum 5 years' experience of supply of equipment and accessories for Handloom in different Departments of Central Govt./PSU/State Govt. Necessary proof in this regard such as a copy of work completion certificate from the competent authority should be submitted.
- iv. The bidder should have experience to complete similar orders of a minimum value of Rs. 20 Lakh in any one year in the last 5 years (FY 2024-23, 2023-22, 2022-21, 2021-20 & 2020-19).
- v. The average annual financial turnovers during the last three years i.e. 2020-21, 2021-22 & 2022-23 should be at least 41 lakhs. Certificate from Registered Chartered Accountant/ Statutory Auditor indicating annual financial turnover during the last 3 years ending 31st March, 2023 shall be furnished.
- vi. The bidder should submit the Bills of purchase of Wood for manufacturing the looms and TP along with the Bill for payment.
- vii. should not been blacklisted/debarred/suspended/banned from business dealing by the World Bank/any Ministry/Department of State/Central Government/PSU as on date of filling the responses of this RFQ; (Self Declaration on agency's Letterhead)

9. Signing of Quotations:

The name and position held by each person signing the quotation and related documents must be typed or printed below the signature.

10. Evaluation of Quotations:

- a) The SPD, ARIAS Society shall evaluate and compare the quotations determined to be substantially responsive, i.e. which,
 - i. are properly signed and sealed;
 - ii. have submitted the required documents and meet the criteria specified as indicated above;
- b) Evaluation shall be carried out on the basis of the total price quoted for all the services.
- c) Mere submission of quotation does not entitle a bidder for award of contract.

11. Award of contract:

- a) The SPD, ARIAS Society shall award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- b) Notwithstanding the above, the SPD, ARIAS Society also reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- c) The bidder whose quotation is accepted will be notified of the award of contract by the SPD, ARIAS Society prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.

12. Delivery Location:

The "Supply & Installation of Improved Fly Shuttle Frame Loom with Accessories & Jacquard (Ball Bearing) with Accessories" for Bodoland Eri Mission (BEM) under APART in BTR should be delivered to the concerned office of Sub-Divisions i.e. Bhergaon, Tamulpur, Kokrajhar and Baksa of the Project districts for inspection by the District Level Technical Committee (which will be notified by the Director of Sericulture, BTC, Kokrajhar) for inspection of looms and Jacquards. The bidder should submit the Purchase bill of wood & Transit Permit (TP) of the supplied materials to the District Level Technical Committee. After acceptance by the above committee the looms will be installed by the manufacturer at the selected beneficiary's premises. (As per Annexure III)

13. Warranty Period:

The warranty for the supplied goods shall be for a period of minimum 90 days from the date of supply. During this period the bidder in the event of any defects shall repair or replace the detective goods. The warranty for the repair/replaced material shall be extended to a further period of 90 days and the Performance Bank guarantee for proportionate value shall be extended 90 days over and above the extended warranty period.

14. Performance Security:

Within seven (7) days of the receipt of notification of award from the Purchaser, the successful Bidder shall furnish the 5% of the contract values as Performance Security drawn from nationalised bank/scheduled bank in favour of the State Project Director, ARIAS Society, Assam and payable at Guwahati. The Performance Security may be in the form of FDR/Term Deposit which shall have a validity period of minimum 90 days beyond the successful supply, installation & commissioning of the Goods.

15. Payment:

Payment shall be made upon satisfactory supply, testing, acceptance and commissioning of the goods. If after supply, it is discovered that the items supplied are not exactly according to the specification/quality mentioned, such supply will be rejected at the supplier's cost.

- a) For the supplied materials, 80% cost will be borne by APART and 20% of the cost will be borne by the beneficiaries.
- b) After delivery and installation of the supplied looms & Jacquards at the premises of beneficiaries, supplier has to submit the bills in triplicate along with delivery challans, Purchase Bills of wood, Transit Permit (TP), photographs of the installed loom and Jacquard with beneficiaries, report of testing, verification and installation by the constituted committee by the Director, BTR, Kokrajhar.
- c) The selected bidder shall raise the invoices as follows; i) 80% of the cost of supply in the name of State Project Director (SPD) ARIAS Society and ii) the balance 20% of the cost of supply in the name of Director, Sericulture, BTR, Kokrajhar.
- d) The State Project Director (SPD), ARIAS Society shall release 80% of the cost of supply after proof of payment of 20% of cost of supply by the Director Sericulture, BTR, Kokrajhar.
- e) No advance payment shall be made.

16. Liquidated damage:

In case of delay in Service Delivery, a Liquidated damage @0.5% of the contract price for every 7 (seven) days of delay shall be imposed and the corresponding amount shall be deducted from the bill(s).

17. Force Majeure:

- (a) **Definition:** For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party and which makes a Party's performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances.
- (b) If either Party is prevented from or delayed in performing any of its obligations under the contract by an event of Force Majeure, then it shall notify the other in writing of the occurrence of such event and the circumstances thereof within ten (10) days after the occurrence of such event. The Party who has given such notice shall be excused from the performance of its obligations under this contract for so long as the relevant event of Force Majeure continues and to the extent that such Party's performance is prevented or delayed. The occurrence of any event of Force Majeure affecting either party shall not give rise to any claim for damages or additional costs and expenses suffered or incurred by reason of Force Majeure.
- (c) **Extension of Time:** Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

18. Corrupt/Fraudulent Practices:

- (a) ARIAS Society requires that the bidder should observe the highest standards of ethics in discharge of the service.
- (b) ARIAS Society can declare the bidder ineligible from competing in any future assignments after giving opportunity of being heard, either indefinitely or for a stated period of time, if at any time it is found that the bidder has engaged in corrupt and fraudulent practices in acquiring, or in executing this work.
- **19.** Any dispute between the Parties will be resolved amicably. In case the dispute is not resolved even within one month of notifying of occurrence of such dispute by one party to the other party, the same shall be dealt as per Indian Arbitration and Conciliation Act, 1996.
